ORDINANCE PROPOSING SERVICE AREA ELECTION

ORDINANCE NO. 2023-56. An Ordinance Altering The Boundaries Of Wildview Service Area To Include Lots 1-8 Block 1, Lot 1 Block 4, Fox Bluffs Subdivision; Lots 9-13 Block 1, Fox Bluffs Subdivision 1st Addition; Lots 1, 11-13 Block 3, Fox Bluffs Subdivision 2nd Addition; Lots 2, 3, 9, 10 Block 1, Lots 1, 7, 8 Block 2, Fox Bluffs Subdivision 3rd Addition; Lots 4-6, Tract B-1 Block 3, Fox Bluffs Subdivision 4th Addition; Lots 2-6 Block 2, Fox Bluffs Subdivision 5th Addition; And GI-3 And GI-4, Section 8, Township 1 North, Range 1 East, Fairbanks Meridian, Alaska, And Providing For One Election. (Sponsor: Mayor Ward)

COMMITTEE OF THE WHOLE AND PUBLIC HEARING

This ordinance is scheduled to be heard before the Assembly sitting as the Committee of the Whole at a worksession October 5, 2023, at 5:30 p.m. in the Mona Lisa Drexler Assembly Chambers, 907 terminal Street, Fairbanks. Citizen comments are not taken during the worksession, but it is open to the public to listen to the staff report and questions/discussion of the Assembly regarding the ordinance.

Public Hearing will take place on Thursday, October 12, 2023, at or after 7:00 p.m., at the same location. If the ordinance is adopted, an election will be held on November 21, 2023.

VOTING IN THE SERVICE AREA ELECTION

If the ordinance is adopted, an election will be held on Tuesday, November 21, 2023. **Ballots are not automatically mailed.** All voting in service area elections is done by absentee voting (either absentee in person, by fax or by e-mail.)

TO VOTE:

- Vote absentee in person at the Clerk's Office beginning October 23, 2023, through November 21, 2023 (excluding weekends and holidays) from 8 a.m. to 5 p.m.
- Vote absentee by mail or electronic transmission by completing an absentee ballot application and having a ballot sent to you. Applications can be found online at: www.fnsb.gov/SAElections, or picked up at the Clerk's Office.

VOTER QUALIFICATIONS

Receipt of this letter does not automatically qualify you to vote. You must be a resident of and registered to vote at an address within the boundaries of the Wildview Service Area at least thirty days prior to the election.

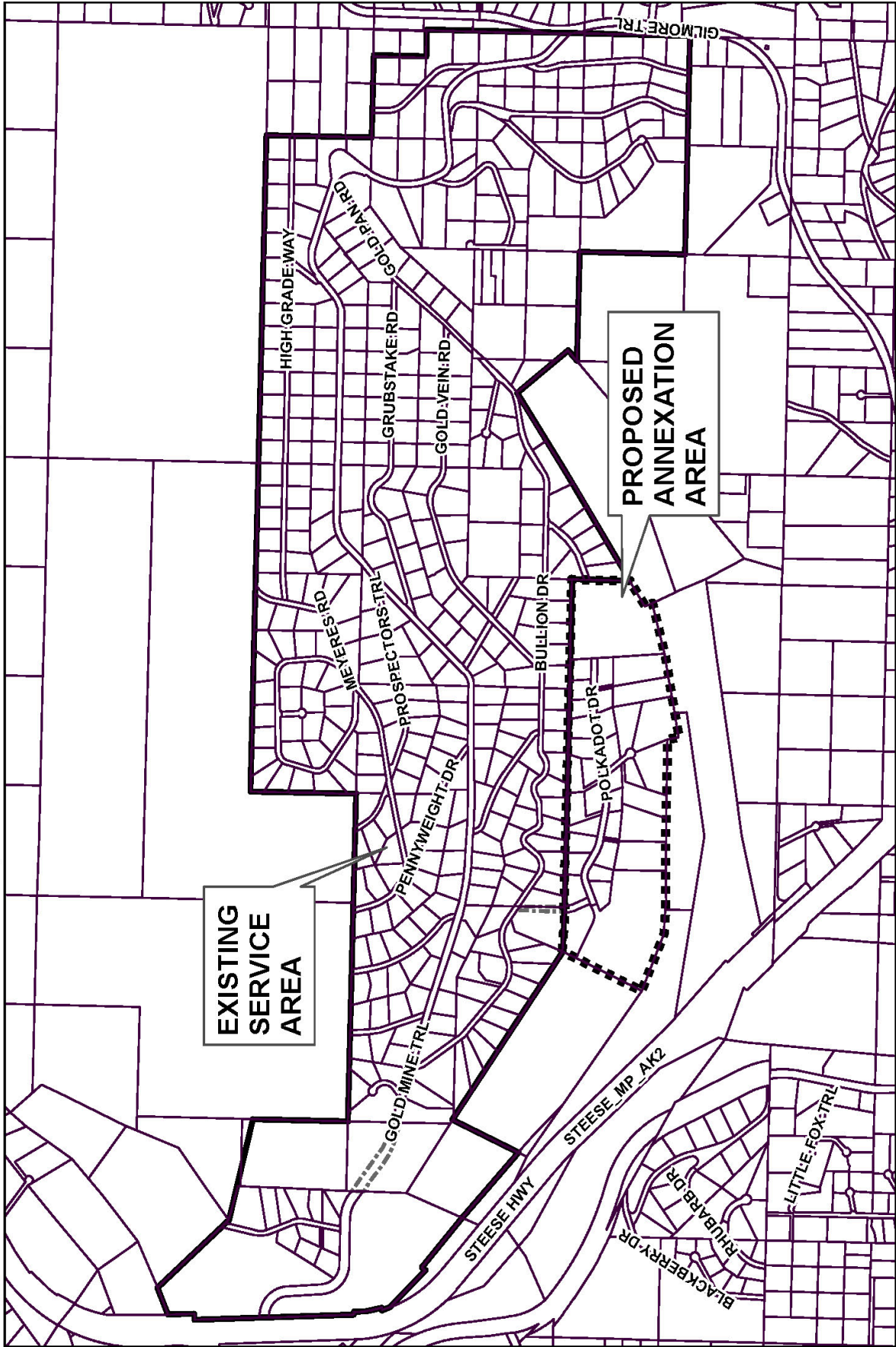
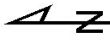
