REGULAR SOLID WASTE	<p>Residential - Accepted free of charge. Commercial - \$127/ton (2,000 lbs)</p> <p>Regular Solid Waste generated outside the FNSB:</p> <ol style="list-style-type: none"> Disposal of less than 25 tons per month of solid waste accepted at 200% of Regular Solid Waste rate. (\$254/ton) Disposal of more than 25 tons per month of solid waste: download an application from our website. Rate for approved projects will be 200% of Regular Solid Waste rate. (\$254/ton) 	<p>RESIDENTIAL: Loads from a “residence in a passenger vehicle, pick-up truck, or a trailer with two wheels and a single axle, or four wheels and a double axle will be considered minor loads.” <i>(Ordinance 21.20.090A)</i></p> <p>Lumber, pipe, cable, etc., must be less than 8 ft. in length. All loads must be tarped or secured.</p>
BRUSH	<p>Residential - All loads accepted free of charge. Commercial - Same as Regular Solid Waste.</p>	<p>Trees, brush, stumps, leaves, branches, roots, undergrowth</p> <p>Loads must not include regular Solid Waste</p>
JUNK AUTOMOBILES 	<p>Residential - Accepted free of charge Commercial - \$50/each</p>	<p>Must be free of trash or debris. Refer to the above website for Automobile Disposal Form and requirements. Ownership title is requested.</p>
HOUSEHOLD APPLIANCES  (Washers, dryers, freezers, stoves, refrigerators, etc.)	<p>Same as Regular Solid Waste Commercial -Additional \$110.00 charge per appliance that contains Freon</p>	<p>Certificate of removal required to avoid \$110.00 charge.</p>
MOBILE HOMES	<p>Same as Regular Solid Waste</p>	<p>Refer to website for Project-Checklist-(fnsb.gov)</p>
SCRAP METAL 	<p>Same as Regular Solid Waste</p>	<p>Metal pieces, etc., must be less than 8 feet in length.</p>
METAL CONTAINERS  (drums & tanks)	<p>Same as Regular Solid Waste</p>	<p>Must be clean and have one end completely cut out. Metal containers larger than 500 gallons must be cut into sections no larger than a 500 gallon container.</p>
CONSTRUCTION DEBRIS	<p>Same as Regular Solid Waste</p>	
LOADER ASSISTANCE	<p>Residential - Free of charge. Commercial - \$3.00/minute.</p>	
ALUMINUM 	<p>Accepted free of charge</p>	
ASBESTOS	<p>Asbestos material generated within the FNSB, accepted at \$191/ton, plus \$75* flat rate fee per load of asbestos brought to the Solid Waste Facility.</p> <p>Asbestos material generated outside the FNSB:</p> <ol style="list-style-type: none"> Disposal of less than 25 tons per month of asbestos accepted at 200% of Regular Solid Waste rate (\$254/ton), plus \$75* flat rate fee per load of asbestos brought to the Solid Waste Facility. Disposal of more than 25 tons per month of asbestos: download an application from our website. Rate for approved projects will be 200% of Regular Solid Waste rate (\$254/ton), plus \$75* flat rate fee per load of asbestos brought to the Solid Waste Facility. <p>* \$300 flat rate fee for customer-caused asbestos discrepancy</p>	<p>Parties interested in disposing asbestos are required to complete a Waste Shipment Manifest prior to disposal, which is located on the FNSB Solid Waste website.</p> <p>Metal pieces, etc., must be less than 8 feet in length.</p>
